How should I use this medicine?

Take this medicine by mouth with food. Follow the directions on the prescription label. Use a specially marked spoon or container to measure your dose. Household spoons are not accurate. Before taking this medicine mix your dose in a glass with 3 to 4 ounces of cold water or juice. Take your medicine at regular intervals. Do not take your medicine more often than directed. Do not stop taking except on your doctor's advice.\n\nTalk to your pediatrician regarding the use of this medicine in children. Special care may be needed.

Overdosage: If you think you have taken too much of this medicine contact a poison control center or emergency room at once.\nNOTE: This medicine is only for you. Do not share this medicine with others.

Where should I keep my medicine?

Keep out of the reach of children.\n\nStore at room temperature between 15 and 30 degrees C (59 and 86 degrees F). Protect from light and moisture. Throw away any unused medicine after the expiration date.

NOTE: This sheet is a summary. It may not cover all possible information. If you have questions about this medicine, talk to your doctor, pharmacist, or health care provider.

What should I watch for while using this medicine?

Visit your doctor or health care professional for regular check ups. You will need lab work done regularly.\n\nYou may need to be on a special diet while taking this medicine. Ask your doctor.\n\nSide effects like stomach upset, nausea and diarrhea happen more when this medicine is not mixed properly or taken without food. Follow mixing instructions exactly each time you take a dose.

What is this medicine?

POTASSIUM CHLORIDE (poe TASS i um KLOOR ide) is a potassium supplement used to prevent and to treat low potassium. Potassium is important for the heart, muscles, and nerves. Too much or too little potassium in the body can cause serious problems.

This medicine may be used for other purposes; ask your health care provider or pharmacist if you have questions.

What should I tell my health care provider before I take this medicine?

They need to know if you have any of these conditions:\n\n -Addison's disease\n -dehydration\n -diabetes\n -heart disease\n -high levels of potassium in the bloodn -irregular heartbeat\n -kidney disease\n -recent severe burn\n -stomach ulcers or other stomach problems\n -an unusual or allergic reaction to potassium, other medicines, foods, dyes, or preservatives\n -pregnant or trying to get pregnant\n -breast-feeding

What if I miss a dose?

If you miss a dose, take it as soon as you can. If it is almost time for your next dose, take only that dose. Do not take double

What side effects may I notice from receiving this medicine?

Side effects that you should report to your doctor or health care professional as soon as possible:\n\n -allergic reactions like skin rash, itching or hives, swelling of the face, lips, or tongue\n -black, tarry stools\n -breathing problems\n -confusion\n -fast, irregular heartbeat\n -feeling faint or lightheaded, falls\n -low blood pressure\n -numbness or tingling in hands or feet\n -unusually weak or tired\n -weakness, heaviness of legs\n \nSide effects that usually do not require medical attention (report to your doctor or health care professional if they continue or are bothersome):\n\n -diarrhea\n -nausea, vomiting\n -stomach pain
